The new Court of Protection started work on 1st October 2007. It deals with decisions about people's healthcare, where they live, their money and what they own.

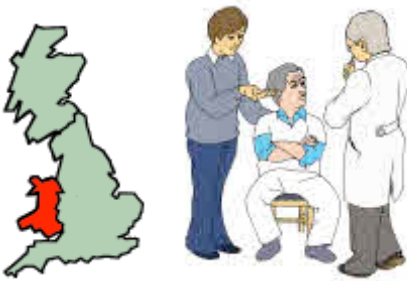

You will be able to get the Code of Practice, forms and information on the website.

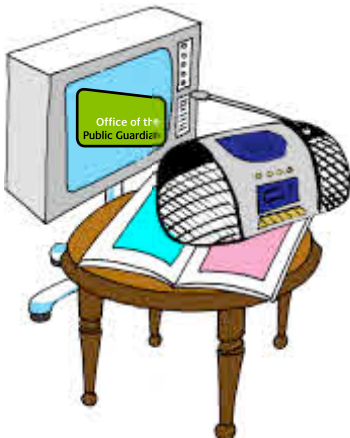


Telling people about the Mental Capacity Act

There has already been information about the Act in the Financial Times newspaper and BBC radio.

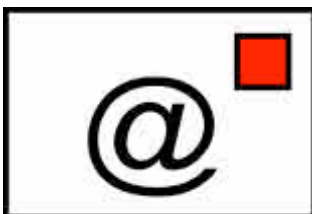

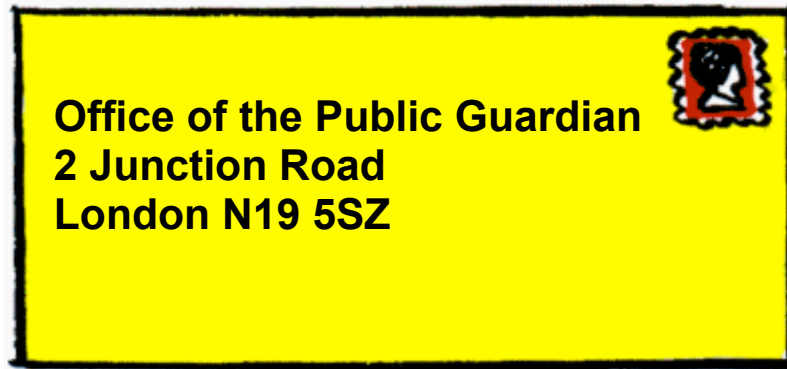

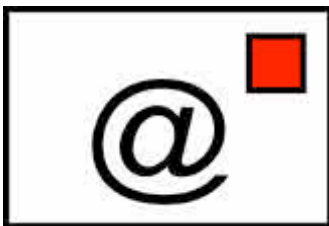

What the words mean

Court of Protection

The new court which deals with everything to do with the Mental Capacity Act. The court decides what is best for people who cannot decide for themselves.

IMCA – Independent Mental Capacity Advocate

Someone who speaks up for people who have no family or friends. They help when important decisions have to be made by the NHS or local authorities. Decisions can be about things like serious medical treatment or moving to a hospital or care home.

OPG - Office of the Public Guardian

This is a new office set up under the Mental Capacity Act. It will:

- help the Court by looking after the paperwork and applications for Lasting Powers of Attorney and Deputies
- keep an eye on Deputies to make sure they are doing their job properly
- work with the police and social services when they think that somebody may have been abused.
